1. Project Information

1.1 INTRODUCTION

The Victorian Department of Transport's Transporting Arts Pilot Program, working together with Metro Trains, Yarra Trams, V/Line, VicTrack and local councils, aims to enliven the community and passenger experience at transport hubs across Victoria, through public art installations by local artists.

Ballan Station has been selected as a location for an artwork installation as part of the Transporting Arts Pilot Program in 2024.

We are looking for artists based in Moorabool Shire (individuals, groups or collaborations) to submit an Expression of Interest for this art commission.

We are looking for artwork that reflects the unique nature of Ballan and its surrounds; the lived experience, natural environment and its stories (these could be contemporary or historical, symbolic or personal). The successful proposal will be designed to have broad appeal and resonate with a local and visiting audience with an impactful visual presence.

Your finished artwork will be digitally reproduced on vinyl wraps and fixed onto the concrete pylons indicated in the Expression of Interest.

1.2 COMMISSION GUIDELINES

Applicants are advised to read the guidelines thoroughly before proceeding with an application.

Artist acknowledgement

A small attribution information panel noting the artist and the work will be displayed on site. The three partners may use the image to promote the artist's work and will acknowledge them in relevant marketing or promotional material specific to this project.

Artist agreement

The successful artist/s will meet with the Department of Transport to discuss and enter into an agreement signed by all partners.

Artwork copyright

Artwork copyright will remain with the artist at all times. Department of Transport, Transport Operator VLine and Moorabool Shire Council retains the right to use images of the installation in future promotions of the Transporting Arts Program or other community activity promotion. Every effort will be made to acknowledge the artist when images of the work are used.

Artwork maintenance

Artwork will be maintained by the Department of Transport and Transport Operator VLine for a minimum of 12 months following installation.

Assessment

The artwork will be assessed by members of the Department of Transport, Transport Operator VLine and a Moorabool Shire Council delegate. Assessment criteria includes:

- Strength of creative vision and design
- How the artwork responds to the context and reflects local community
- Originality of the design

Eligibility

Artists (individuals, groups or collaborations) who apply must live or work in Moorabool Shire. First peoples and multicultural communities are strongly encouraged to apply. Students may apply however, the proposed activity must not be associated with the completion of a course of study.

Remuneration

Artists will receive an artist fee for the successful work submitted and it will be mounted on the tram shelter. A fee of \$2,000 will be provided to the selected artist in return for the production-ready image files. The Department of Transportation will cover separately the costs of printing and installation of the artwork.

Term

The artwork will be installed and maintained/repaired if damaged for a minimum of 12 months. Following this period, and at the discretion of the Department of Transport, the artwork will remain installed depending on its condition and community feedback.


The artwork must not:

- Be offensive or demeaning to the general public.
- Appear to look like graffiti.
- Be used to promote a political party, parties or a political cause.
- Include any commercial content, logos, overt branding or QR codes.
- Resemble, be capable of confusion with informational or wayfinding signage.
- Portray images or events that may cause distress to children.

1.3 MOORABOOL SHIRE COUNCIL

Moorabool Shire is situated to the west of metropolitan Melbourne, encompassing an area of over 2,110 square kilometres and home to over 36,000 residents. As shown in the adjacent map, Moorabool Shire is strategically located at the gateway to western regional Victoria, between metropolitan Melbourne and the regional centres of Geelong and Ballarat. The municipality is comprised of 64 localities, hamlets and towns, including the key urban centres of Bacchus Marsh and Ballan. Most settlements are small and rural towns provide support and services for local industry, residents and visitors.

The municipality is a 'Peri-Urban' Council experiencing rapid urban and population growth, particularly in the eastern region of the Shire – across Bacchus Marsh and Ballan – with the number of residents expected to almost double in the next 20 years. This urban development contrasts with the large tracts of rural land and traditional agricultural sector, as well as the large volume of land (74%) comprising water catchments, State Forests, State Parks and National Parks. The collection of natural assets and peri-urban environment creates significant lifestyle and economic benefits for residents, businesses and visitors.




1.4 SITE INFORMATION

As part of the Victorian Government's Big Build, Ballan Station was upgraded in 2021, including the addition of a pedestrian overpass. The two concrete pylons supporting the overpass have been identified as an opportunity for a substantial artwork commission.

The intention is to commission a photo-based artwork, which captures and communicates a story or stories unique to the local area of Ballan and its surrounds. These could be contemporary or historical, symbolic or personal, though the successful proposal will be designed to have broad appeal and resonate with a local and visiting audience with an impactful visual presence.



The selected artwork will be installed on four main faces of two concrete pylons on the station platforms, as indicated in the image above (note the sides will remain clear, the artwork will not wrap around the pylons).



Measurements of the north face of Pylon 1 and Pylon 2 are shown here (with mirror image dimensions to be used for their rear faces). Where possible use these shapes to indicate your concept in your proposal.
